ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.40 per Offer Share (excluding brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.40 per Offer Share, the net proceeds from the Share Offer to be received by the Company (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options that may be granted under the Share Option Scheme), after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$73.2 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and proposed use of proceeds” in the Prospectus.

Applications under the Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 9,614 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 553,895,000 Public Offer Shares, equivalent to approximately 18.46 times of the total number of 30,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- As the Public Offer was very significantly oversubscribed, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Public Offer is more than 15 times of the number of Offer Shares initially available for subscription under the Public Offer, a total of 60,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the final number of Offer Shares under the Public Offer is increased to 90,000,000 Shares, representing 30% of the Offer Shares available under the Share Offer (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options granted under the Share Option Scheme).

Placing

- The Offer Shares initially offered under the Placing have been slightly oversubscribed. A total of 300,000,000 Placing Shares have been subscribed, representing approximately 1.11 times of the total number of 270,000,000 Placing Shares initially available for subscription under the Placing, representing 90% of the Offer Shares available under the Share Offer (before any exercise of the Over-allotment Option and without taking into account the options which have been or will be granted under the Share Option Scheme). The final number of Placing Shares allocated to 240 placees under the Placing is 210,000,000 Shares, representing 70% of the Offer Shares available under the Share Offer (before any exercise of the Over-allotment Option and without taking into account the options which have been or will be granted under the Share Option Scheme).
- The Directors confirm that, to the best of their knowledge, information and belief, having made all reasonable enquiries, no Placing Shares have been allocated to placees who are (i) Directors or existing beneficial owners of Shares of the Company; or (ii) core connected persons of the Company; or (iii) the close associates of (i) and/or (ii), whether in their own names or through nominees. None of the Sole Sponsor, the Underwriters and their respective affiliated companies and connected clients (as set out in Appendix 6 to the Listing Rules) has taken up any Shares for its own benefit under the Placing. The Directors confirm that the Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. The Directors confirm that (i) there will be at least 300 shareholders of the Company at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules; and (ii) the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors further confirm that no placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately following the completion of the Share Offer, and as such, none of the placees under the Placing will become a substantial shareholder of the Company immediately after the Placing within the meaning of the Listing Rules, and the Company's public float percentage will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules after the Share Offer.
